FOR ALL AGE CATEGORIES FOR TOURNAMENT OF AMERICAS:

1. SENIOR APPLICANTS MUST MEET AGE REQUIREMENTS AS OF THE DATE OF T OF A. SUPER SENIOR MEN AND WOMEN ARE ALLOWED TO COMPETE IN THE SENIOR DIVISION BUT, A SENIOR CAN NOT COMPETE IN THE SUPER SENIOR DIVISION. See www.bowlingamericas.com
2. YOUTH APPLICANTS MUST MEET AGE REQUIREMENTS AS OF THE DATE OF T OF A. see www.bowlingamericas.com
3. ALL TEAMS CONSIST OF 2 MEN AND 2 WOMEN, IF THERE ARE NOT ENOUGH PARTICIPANTS TO FILL A TEAM, TEAM WILL NOT PARTICIPATE.
4. APPLICANTS MUST BE MEMBERS OF C.T.F. IN GOOD STANDING.
5. APPLICANTS MUST HAVE A VALID PASSPORT AND **SEND IN WITH APPLICATION.**
6. PARTICIPANTS ARE RESPONSIBLE FOR ALL EXPENSES ASSOCIATED WITH THIS TOURNAMENT TO INCLUDE: AIRFARE, ACCOMODATIONS, ENTRY FEE TO TOURNAMENT OF AMERICAS, EXCESS BAGGAGE FEES AND ANY OTHER TRANSPORTATION COSTS AND ANY TRAVEL INSURANCE.
7. SELECTION PROCESS FOR ALL TEAMS **MAY** BE BASED ON PAST PERFORMANCE AT NATIONAL AND INTERNATIONAL TOURNAMENTS.
8. NO TRAINING CAMPS WILL BE AVAILABLE FOR ATHLETES ATTENDING THIS EVENT.
9. COACHES WILL NOT ATTEND THIS EVENT, UNLESS THEY CHOOSE TO, AT THEIR OWN EXPENSE. A TEAM MANAGER MAY ATTEND IF BUDGETS ALLOW.
10. THE HIGH PERFORMANCE UNIT IS RESPONSIBLE FOR THE SELECTION OF ALL TEAMS AND NOTIFICATION TO THE ATHLETES WHO HAVE BEEN SELECTED.
11. CLOSING DATE FOR APPLICATIONS IS **April 2nd** IF APPLICANT IS CHOSEN ALL FORMS AND TOURNAMENT ENTRY FEE, SHIRT FEE, AND BANQUET FEE MUST BE RECEIVED WITHIN 5 DAYS THE APPLICATION WILL BE VOID AND A NEW SELECTION WILL BE MADE.
12. ALL ATHLETES WILL BE REQUIRED TO SIGN A CODE OF CONDUCT FORM AND A SOCIAL MEDIA FORM. YOU ARE REPRESENTING YOUR COUNTRY AND ANY INAPPROPRIATE BEHAVIOUR COULD AFFECT ANY FUTURE ATTEMPTS TO APPLY OR COMPETE FOR A SPOT ON TEAM CANADA.
